

TIMED EVENT/ROUGHSTOCK EVENTS

These events in most cases are being put on by the Association during Covid to give our membership a rodeo/event to compete in.

All Contestants entering a Timed Event/Roughstock Event must have a current FCA Membership or a membership of a co-approved association. No Local entries (unless a current rodeo committee choses to put on an event then they may ask to have locals)

To be classed as a Timed Event/Roughstock Event – there is no requirement to have added money.

These are being put on by the association to give our members a place to rodeo.

The Stock Fee, Finals Fee, Office & Committee Fee & Barrel Timer Fees will all be charged same as regular season. The entry fees listed below are minimum fees charged.

Dues to time constraints it may be decided by the committee that they are only allowing 1 run/ride per person

<u>TURNOUT RULES APPLY – See Rule Book for Turnout information</u>

The following rules apply:

- 1. In any stock event 33% is deducted from the entry fees and payout is calculated
- 2. In the Barrel Racing events, 30% is deducted from the entry fees and payout is Calculated.
- 3. In the Team Roping
 - a. May be allowed to enter 2x different partners, no cross entries
 - b. All teams dollars count toward season standings
 - c. Entry fees \$80/person/go
 - d. Stock charge of \$10/entry, this will not be calculated in the payout.
 - e. All stock chute ran, no draw
 - f. If payout is less than \$1000/side, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000/side payout will be calculated as stated in the rule book
 - g. All other rules to follow FCA rule book
- 4. In the Calf Roping and Steer Wrestling
 - a. May be allowed to enter 2x
 - b. All dollars count toward season standings
 - c. Entry Fees \$80/person/go
 - d. All stock chute ran, no draw
 - e. Stock charge of \$10/entry, this will not be calculated in the payout.
 - f. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000 payout will be calculated as stated in the rule book
 - g. All other rules to follow FCA rule book
- 5. Breakaway (Ladies & Juniors)
 - a. May be allowed to enter 2x
 - b. All dollars count toward season standings
 - c. Entry Fees \$60/person/go
 - d. All stock chute ran, no draw
 - e. Stock charge of \$10/entry, this will not be calculated in the payout.
 - f. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000 payout will be calculated as stated in the rule book
 - g. All other rules to follow FCA rule book

- 6. In the Ladies Barrel Racing
 - a. May be allowed to enter 2x
 - b. All runs count toward season standings
 - c. Entry fees \$80/run
 - d. Can be 2 times on same horse or different horses
 - e. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000 payout will be calculated as stated in the rule book
 - f. All other rules to follow FCA rule book
- 7. In the Junior Barrel Racing and PeeWee Barrel Racing
 - a. May be allowed to enter 2x
 - b. All runs count toward season standings
 - c. Entry fees \$60/run Junior & \$40/run Pee Wee
 - d. Can be 2 times on same horse or different horses
 - e. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000 payout will be calculated as stated in the rule book
 - f. All other rules to follow FCA rule book
- 8. In the Open Roughstock Events (Saddle Bronc, Bareback, Bull Riding)
 - a. May be allowed to enter 2x
 - b. All dollars count toward season standings
 - c. Entry fees \$80/peson/go
 - d. Stock charge of \$25/entry, this will not be calculated in the payout.
 - e. All stock chute ran, no draw
 - f. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000/side payout will be calculated as stated earlier in the rule book
 - g. All other rules to follow FCA rule book
- 9. In the Junior Stock Events (Junior Bulls, Steer Riding, Novice Horse Riding)
 - a. May be allowed to enter 2x
 - b. All dollars count toward season standings
 - c. Entry fees \$60/person/go
 - d. Stock charge of \$25/entry, this will not be calculated in the payout.
 - e. All stock chute ran, no draw
 - f. If payout is less than \$1000, only 4 holes will be paid, 40,30,20,10, if payout is over \$1000/side payout will be calculated as stated earlier in the rule book
 - g. All other rules to follow FCA rule book
